

KEY FINDINGS OF NATIONAL POLICY ANALYSIS

Global and European organisations provide guidelines for fair and inclusive societies

Countries have **individual national policies** but converge on principles, emphasising a global and local approach

Policy's commitment to **social inclusion**, **education quality**, **equal opportunities**, and **alignment** with global and regional agendas





GLOBAL COLLABORATION AND ALIGNMENT

- Encourage countries to align their national education policies with the principles and objectives recommended by global and European organisations for social inclusion
- Promote international collaboration to share best practices, experiences, and strategies for achieving social inclusion in education

LIFELONG LEARNING AND SKILL DEVELOPMENT

- Emphasise the importance of lifelong learning in education policies, aligning with the changing needs of society and the labour market
- Promote the development of relevant skills that prepare individuals for the challenges of the 21st century, including technological advancements





EQUAL ACCESS AND OPPORTUNITIES IN EDUCATION

- Advocate for policies that ensure equal access to education and opportunities for all students, irrespective of their socio-economic background, ethnicity, or other factors
- Support measures that eliminate barriers to education, such as financial constraints, and promote inclusive practices in schools

INCLUSIVE EDUCATION PRACTICES

- Encourage the adoption of inclusive education practices, such as learner-centred approaches, diversity appreciation, and skill-based education
- Support the implementation of laws and acts that recognise and address the unique needs of different groups, ensuring their full participation in the learning process





PARTNERSHIPS AND COLLABORATION

- Foster collaboration between educational institutions, government bodies, social partners, stakeholders, and the private sector to enhance the quality of education
- Support initiatives that develop networks for sharing knowledge, skills, and experiences, promoting collaboration between different sectors for socio-economic development

POVERTY REDUCTION AND WELL-BEING

- Integrate education policies with broader strategies for poverty reduction and well-being, ensuring collaboration among various stakeholders at regional and national levels
- Recognise the interconnection between education, poverty, and social rights, aligning policies to combat poverty fully and promote inclusive economic development





REGIONAL ALIGNMENT WITH GLOBAL AGENDAS

- Encourage regions to align their educational strategies with global agendas such as the Sustainable Development Goals (SDGs) and the European Pillar of Social Rights
- Support regional laws and initiatives that specifically target the unique needs and rights of the local population, contributing to broader societal goals





These guidelines aim to enhance social inclusion, equality, and educational outcomes by fostering collaboration, aligning policies with global principles, and addressing specific challenges faced by diverse groups within each country.
